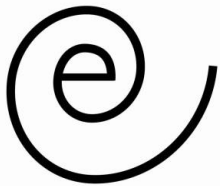
Information Collection and Use via Contact Forms

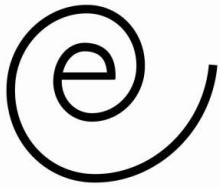
Security
